The undersigned acknowledges that Fleet Guardian, LLC will be using the information set forth on this application as a basis to determine whether to extend credit to the applicant.

In consideration for the extension of credit privileges, the applicant agrees to make all payments for all goods and / or services provided within 30 days of the applicant having been provided said goods and / or services. In the event that payment in full is not received by Fleet Guardian, LLC, the applicant agrees to pay interest on all sums owed at the rate of 18% annually, 1.5% monthly. In the event that the applicant’s account goes over 60 days from date of invoice, Fleet Guardian, LLC reserves the right to charge the applicant 20% for collection expenses. If Fleet Guardian, LLC must refer the applicant’s account to an attorney for collection, or if collected through suit, probate or bankruptcy proceeding, the applicant agrees to pay all expenses incurred by Fleet Guardian, LLC, including, but not limited to, all charges related, in addition to 30% attorney’s fees.
